Introduction

[The last year has been observed as a time of transition in Bathurst's response to Homelessness. Since 2022, the number of people at risk and experiencing homelessness has risen in Bathurst, as have the challenges in responding to their housing and support needs. In response, the City of Bathurst began a focused review of the local housing crisis and the needs of individuals experiencing homelessness beginning in the fall of 2024. Representatives from local government, non-profit organizations, housing, mental health and public health services, public safety and other community stakeholders came together to assess housing challenges and explore immediate solutions. Over the course of the fall, several meetings were convened to ensure that a warming center would be available for the unhoused population during the winter of 2024.

It quickly became evident that Bathurst required more than short-term measures, highlighting the need for sustainable, long-term solutions and the establishment of a Community Homelessness Committee. In early 2025, the Homelessness Strategy Consultant for Northern New Brunswick, continued to engage stakeholders in the committee and held three sessions to review urgent needs and to gain a clearer understanding of current challenges in homeless reduction strategy in the city.

Another feature to the transition in Bathurst, was that the Human Development Council (HDC) was selected to administer Reaching Home, Canada's Homelessness Strategy. Beginning on April 1, 2025, the HDC began a review of its CAB membership and engaging with local leadership within the community's response to homelessness to develop an understanding of the local context, resources and opportunities for partnerships. On July 3rd, the HDC participated in meetings with the original CAB and



Homelessness Committee Members and completed discussions and approval towards amalgamating the two tables. During that same meeting the HDC reviewed the CAB requirements, and Reaching Home Directives. Action items included updating Terms of Reference for the group and reviewing membership to ensure it is reflective of community and the essential services required to respond and reduce homelessness. It was also agreed that broader community engagement sessions would be essential to fully capture the scope of the issue. Throughout the 2025 summer work was completed to broaden representation of the CAB and assign designated representatives from participating organizations/entities.

The Bathurst CAB is currently comprised of representatives from: Bathurst Fire Services, Bathurst Police Force, Bathurst Volunteer Center, Chairperson of the Ministerial Association of Bathurst, Community Entity, Chaleur Regional Service Commission, Emergency Department Bathurst Regional Hospital, Housing, Infrastructure, and Communities Canada, AIDS New Brunswick, Maison Passage, Mental Health and Addictions, NB Housing, Pabineau First Nations, persons with lived or living experience of homelessness, Psychiatry Department Bathurst Regional Hospital, Public Health – Population Health, Public Health – Immunizations and Communicable Diseases, Shelter Coordinator, the Homelessness Strategy Consultant, and the Disability Support Program Manager.

The communities of Bathurst and the Chaleur Region have been facing increasing challenges related to social issues. In response, there has been a growing effort to foster collaboration between Indigenous and non-Indigenous partners. Representatives from Pabineau First Nation have actively participated in community discussions focused on key priorities such as transportation, food security, housing, and homelessness. Pabineau First Nation have a table at the Regional Service Commissions permanent committee on community development and have been engaged with partners in developing recommendations on social issues, including housing and homelessness. When the CAB increased its representation, it included a representative from Pabineau who contributed to the review of the Reaching Home Community Template and the planning details of a full-day engagement session. However, the Community Planning Session held on September 25 coincided with the annual moose hunt, which prevented the representative from attending.

On August 21, 2025, the CAB met in advance of a planned September full day session, to review the Community Plan Template. Members were asked prompting questions to consider in the lead up to the September session and were also provided with the Community Plan and Reference Guide.

On September 25, 2025, the Bathurst CAB met to complete the Community Plan. Investments, schedule and Coordinated Access were discussed in conjunction with the reality that Bathurst is facing increasing demand for housing and support services. Planning discussions emphasized the importance of targeted responses to the needs of individuals experiencing homelessness, while also identifying opportunities to strengthen and expand existing supports.



The CAB outlined priorities to guide Bathurst's Community Plan for the next 2 years. Housing focused services are seen as a priority regardless of the service. The CAB prioritized housing services along with a particular focus on diversion, prevention, and Housing First approaches. A strong emphasis will also be placed enhancing the coordinated access to ensure we are strengthening connections to family, peers, and natural supports, while addressing barriers related to education, employment, and housing stability.

The Bathurst Community Plan represents a collective vision to foster an inclusive, resilient, and supportive community where all residents have the opportunity to thrive.]

[The Bathurst CAB reviewed and discussed activities that would help improve the coordinated and data driven service delivery of resources currently available and integral to responding and reducing homelessness in Bathurst. There was a general interest to not duplicate, but to better streamline any present effort towards having a good inventory and referral process to access of local services. There was also an interest to not overwhelm shelter staff and resources by having all referrals directed to the shelter. There was acknowledgement that further engagement work and 'journey mapping' could deliver ideas on improving access points, assessments and referrals. There was also consensus on the importance of quality data entry, reporting and analysis to strengthen data driven decision processes and advocacy. Overall, there were ideas that a coordinating role could assist with this, but more time was recommended to complete this discussion.]
